AN ACT

To appropriate the sum of \$260,000 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for Special Education Program in the Department of Education during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1. The sum of \$260,000, or so much thereof  
2       as may be necessary, is hereby appropriated from the  
3       Special Revenue Fund of the State of Yap for the purpose  
4       of providing funding to fund Special Education Program in  
5       the Department of Education during Fiscal Year 2025. The  
6       sum appropriated shall be deemed from United States  
7       Federal Grants identified as Grant No. H027A240005.

8           Section 2. Conditions and Restrictions.

9           (1) Funds appropriated by this Act shall not  
10      be available for obligation for their planned uses by the  
11      agency until the respective grant cash amounts have been  
12      drawn down by the State and are deposited in their  
13      respective State accounts and available for disbursement.

14           (2) The sum appropriated by this Act shall  
15      not be advanced to the agency. Memorandum of  
16      agreement (MOA) or other forms of agreement the purpose of  
17      which is to obligate and disburse to the agency any  
18      amounts from the sum appropriated herein, including

1       reimbursements    for    payments    is prohibited.

2                       (3)    All funds appropriated by this Act shall  
3    be maintained under the authority of the Director of the  
4    Office of Administrative Services.

5                       Section 3. Allotment and Management of Funds, and  
6    Lapse Date.    The sum appropriated by this Act shall be  
7    allotted to the Governor who shall be responsible for  
8    ensuring these funds are used only for the purposes  
9    specified under Section 1 of this Act.    The sum  
10   appropriated by this Act shall be administered in  
11   accordance with the provisions of applicable law,  
12   including, but not limited to, the State Financial  
13   Management Act of 1983 and the State Contracts Act.    The  
14   authority to obligate the funds appropriated by this Act  
15   shall lapse as of September 30, 2025, and any part of  
16   this appropriation not obligated as of September 30, 2025  
17   shall revert to the Special Revenue Fund of the State of  
18   Yap.

19                       Section 4. Reports.    The Governor shall submit to  
20   the Legislature the performance and financial quarterly  
21   reports for each quarter in each fiscal year no later  
22   than twenty days after the end of each quarter.    Each

1       quarterly report shall include, but not limited to,  
2       complete descriptions of the obligations incurred against  
3       the funds appropriated by this Act, and the status of  
4       the Funds as of the end of the completed quarter.

5           Section 5. This Act shall take effect upon its  
6       approval by the Governor, or upon its becoming law  
7       without such approval.




